Student Information Spring Semester 2022

Critical Changes

Similar to Winter Intersession, students registering for and planning to attend inperson/face to face classes or hybrid classes or to attend/participate in services like tutoring, the library, counseling, or other programs and activities on campus MUST be vaccinated or immediately vaccinate and upload proof to the CLEARED4 system.

LA County Department of Public Health [1.7.22] is stating that students and employees who are not fully vaccinated and boosted are to be tested weekly ("weekly asymptomatic screening testing for those not up to date with vaccines"). This will begin for the Spring 2022 semester.

Registration

Students are allowed to register for in-person, hybrid, and fully online courses for Spring semester without having submitted any proof of vaccination. However, there are critical verification and drop dates if students fail to upload their vaccination records.

Process

Students receive emails from "no-reply@cleared4work" with their link to upload vaccination records/results.

Uploading vaccination records

- 1) Search your student email from Cleared4 for your unique account link
- 2) Load your vaccination card into cleared4
- 3) Make sure to indicate every dose, not just the latest one
- 4) Find Cleared4 Step by Step help at www.mtsac.edu/studentservices

Cut Off and Drop Dates

- Friday, February 11 (7:59 PM):
 - Drop for Non Payment students who have not paid fees for Spring or have not filed a CCPG fee waiver or applied for Pell through FAFSA, or have any other financial abeyance, will be dropped if they have not paid their fees. This includes the additional fees for AS, transportation, additional health fee.
 - Drop for Vaccination Non-Compliance students will be dropped from classes which are scheduled to meet in person (have a location on campus), including hybrid courses, labs, regular tutoring attendance or library visitation) if they have not uploaded at least the first dose of a 2part vaccination or the 1-dose if Johnson and Johnson vaccination
 - Medical or religious exemption requests are due to hraccommodations@mtsac.edu

- Thursday, February 17 (2:00 PM):
 - Drop for Non-Compliance (no vaccination proof at least first dose or no approved exemption) if enrolled in any face:face/in person or hybrid class. [Class has a room location]
 - Warning Notice for February 17 Drop: Send emails to students; run lists of students enrolled in special programs; post notices
 - First warning for Feb 17 drop: February 4, 2022
 - Second warning for Feb 17 drop: February 11, 2022
- Friday, March 25 (2:00 PM):
 - Drop for Non-Compliance (if 2nd dose of 2-shot vaccination not received) and if enrolled in any face:face/in person or hybrid class.
 - Warning Notice for March 25 Drop: Send emails to students if 2nd dose hasn't been recorded:
 - First warning for March 25 drop: Friday, March 11
 - Second warning for March 25 drop: Friday, March 18
