Major Capital Construction Projects

The Measure RR and Measure GO building program is proceeding ahead of schedule with nearly 200 active projects ranging in value from \$25,000 to over \$200 Million, including nine major projects under construction, two major projects under review by the Division of the State Architect (DSA), and two major projects in the design phase. The following chart shows the status and occupancy dates for select major capital construction projects:

Major construction activities related to the Temple Avenue pedestrian bridge, new signalized intersection, and green corridor landscape improvements will continue throughout the next two semesters, with intermittent traffic impacts along Temple Avenue between Mt. SAC Way and Bonita Drive. Within the central campus zone, major work will continue through the spring semester of 2024 at the campus store and instruction offices site, just south of the student center. Significant effort has been made in planning the transition to occupancy at the south side of the student center in 2023 while the adjacent new campus store and instruction office project contractors begin heavy construction activities.

As the new technology and heath facility is set to begin construction in the spring of 2023, the central campus construction zone will also expand to the east up to the site of the new transit center. The planning and logistics necessary to get workers, material deliveries, and equipment coordination to such impacted project sites presents a complex challenge. The college project managers, with the support of our construction management

firm, Tilden Coil Constructors, prime contractors, and consultants are continually reviewing site conditions, pedestrian pathways, emergency vehicle access, and work plans to minimize traffic impacts and to maintain the highest safety standards around the active sites. Planning activities also include efforts to seek incremental agency approval of early project activities, such as grading, earthwork, and demolition, to both improve safety around project sites, and to minimize construction noise effects on adjacent buildings. As we reach the end of 2021 with so much active construction, we have a very good picture of what to expect on campus for the next five years. The specific locations will change as projects start and finish, but we can expect to see multiple major projects within the academic zone throughout 2026. Staff, faculty and students should be reminded at every reasonable opportunity to pay close attention to their surroundings, to follow directional signage, and to watch for construction vehicles that may be sharing the roads in and around campus.

Minor-Capital Construction, Interior Renovation, and Alteration Projects

The project teams are also engaged with several significant minor capital improvement projects across campus. In the student services area, work is planned within buildings 9B and 9A (Student Services and Bookstore) during the winter session to realign spaces to meet current program needs. A new 4,000 GSF instructional support space modular facility will be constructed to the west of the humanities building (26 A) and just east of the equity center. The facility will provide long term space for the El Centro Latinex Chicanex Student Program, supporting the program goals to support, educate, and assist students while providing cultural enrichment and solidarity between Mt. SAC students and surrounding communities. The project design is currently awaiting agency approval, with the goal of the one-year construction phase starting in the 2022 spring semester.

Other critical minor capital projects ongoing this fall include: the creation of a STEM center on the third floor of the math and science building (61), repurposing modular units 18C and 18D for use near the college warehouse, lighting upgrades at the fine arts buildings (1B and 1C), classroom interior improvements at 11 rooms in the humanities buildings (26A-D), heating and cooling system improvements at the equity center (16E), the Professional and Organizational Development (POD) relocation to the second floor of the library/learning technology center (6), and the subsequent reassignment of the former POD spaces to the Center for Black Culture and Student Success program. Several minor capital projects set to begin the design phase this quarter, and will be prioritized along with new facilities improvement requests that have come through the Planning for Institutional Effectiveness (PIE) process. Note that the PIE committee has been working on certain process improvements that will yield better defined more accurate project requests by engaging the facilities planning team earlier in the process so that rough cost estimates, feasibility, and constructability reviews, with recommendations can be included in unit level PIE resource requests.

Long Range Planning

The facilities planning team is primarily engaged in three types of planning efforts that look at long term facilities needs for the college. Planning for future projects, including those to be funded primarily with state capital

outlay funds and/or measure GO, and projects that may require additional funds beyond measure GO, is focused on developing space and adjacency needs, site planning, and looks to reuse and repurpose existing facilities where possible. When existing facilities cannot feasibly be repurposed, project specific planning identifies and proposes new building locations on campus, and develops a conceptual plan that provides the scope of work and estimated costs for future work. Project concepts are in the development phase for new facilities including the new library and the school of continuing education and instructional village project, and for secondary effects projects such as the modernization and reconstruction of the existing library and learning technology facility (6), the existing health careers buildings (67A and 67B), and portions of the administration building (4). Future project planning for a new student services facility, a new science laboratory building, and a replacement or modernization of the fine arts building (1A).

The facilities planning team is also engaged with a number of campus-wide studies to including a wayfinding and signage plan, and exterior lighting at campus streets, walkways and parking lots that will feature the necessary infrastructure for expanded wireless connectivity across campus. Other camps-wide studies currently underway include a new renewable energy plan, and an update to the utility infrastructure plans.

Finally, the facilities planning team is developing a precinct, or zone plan for future facilities and infrastructure across the north campus area. This will provide specific information necessary for the next facilities master plan update, scheduled to start in 2022.

Efforts to develop and implement sustainable facilities and infrastructure and included in all aspects of facilities planning, design and construction.

Deferred Maintenance

On July 30, 2021, the college received instructions from the chancellor's office defining deliverables and constraints for the current fiscal year allocation of \$15.6 Million for deferred maintenance. The new funding will greatly expand college efforts to reduce an extensive backlog of scheduled maintenance projects, and will fund new accessibility improvements, water conservation projects, and replacement of instructional equipment. The state funds come with an aggressive time schedule, with all funds expected to be encumbered by June 30, 2023. The following goals have been identified for the deferred maintenance program:

- 1. Reduce the deferred maintenance backlog of critical building systems where no major capital improvement projects are planned within the next 5 -10 years.
- 2. Renew interior public and teaching spaces in facilities that are at least 10 years old.
- 3. Upgrade classroom audiovisual systems that have reached or exceeded their useful lifespan.
- 4. Upgrade public restroom facilities to improve accessibility and cleanliness.
- 5. Replace inefficient irrigation systems.
- 6. Replace specialized instructional equipment and student seating.

Work is well underway to develop an extensive list of projects that meet these goals. Over the next few months, the project list will be submitted to the state for review, prioritized with appropriate input from across campus, and developed into work packages that can be placed for public bidding. The work will include both interior and exterior improvements, and will require a high level of oversight and coordination, especially for work in or adjacent to occupied buildings.

Construction Safety

The college is experiencing an unprecedented volume of construction, with expenditures in excess of \$100 million annually. The pace of work will continue at current levels throughout the next four to five years. Throughout this time, the safety of students, staff, and our construction teams require our very best efforts. Working safely is everyone's job, and the facilities team, along with risk management specialists, police and campus safety, and our construction management firms are fully committed to maintaining a safe workplace and study space for our students.
