1.	Ongoing funding to support digital signage	The campus' digital signage platform, Carousel, is changing their business model to a cloud hosted subscription based system. If we do not migrate our digital signage systems to this new service model, the systems will no longer be supported and we will lose the ability to update content. The Audio Visual Services team evaluated other systems (Newreach and 22 Miles) over the last few months to find an alternate product. Both of the other manufacturers were significantly more expensive than the current vendor, Carousel. Ongoing funding is needed to keep the existing campus signage systems working. The current annual cost per signage player is \$195, and are 84 licenses needed. Additional ongoing funding will be needed next year to incorporate new signage systems that are being installed with current construction projects and to provide funding for any rate increases.	16,380.00		16,380.00


