

Grants Quarterly Update

April 18, 2023

Mt. SAC submitted the following new grant applications in the third quarter of FY 2022-23:

1. Arthur N. Rupe Foundation – Certified Nursing Assistant (CNA) Program Grant
 - This grant application was submitted and awarded during the third quarter.
 - The project lead is Suzanne Avila, Professor of Short-term Vocational Health Care Programs.
 - The award is \$25,000 over a one-year period.
 - This project will increase the college’s capacity to meet the workforce and student demand for the CNA program. In addition to providing tutoring, counseling, expanded lab hours, and certification exam preparation, the project will also provide scholarships to students with identified need to cover the cost of participation in the program as well as CNA certification exam fees.

2. National Science Foundation – Improving Undergraduate STEM Education, Hispanic-Serving Institutions
 - California State Polytechnic University, Pomona, is the lead and Mt. SAC is a partner on this project titled, “Closing Under-represented Minority Achievement Gaps in the Gatekeeper Courses of the Civil Engineering Program.”
 - The proposed project leads at Mt. SAC are Eugene Mahmoud and Dr. Brandon Saller, Professors of Engineering.
 - The request for Mt. SAC is \$150,000 over a four-year period.
 - If awarded, this project would create opportunities for faculty at the two partner institutions to engage in conversations around lower-division engineering courses and engineering education pedagogy. Mt. SAC faculty will connect prospective engineering transfer students with resources at Cal Poly Pomona to create a smooth transition to the university.

3. California Community Colleges Chancellor’s Office – Culturally Responsive Pedagogy & Practices: Innovative Best Practices
 - The proposed project lead is Dr. Tiffany Kuo, Professor of Music.
 - The request is \$300,000 over a two-year period.
 - If awarded, this project would align and scale-up local, evidence-based DEISAA professional development programs to cultivate inclusive and equity-centered learning environments, including coordinating a team of DEISAA- and data-trained faculty mentors for all academic/counseling divisions; composing a DEISAA self-assessment rubric; proposing possible pathways for instructors to meet DEISAA expectancies; composing and implementing student surveys tailored to different programs and teaching modalities; implementing workshops and a retreat to engage in critical conversations and self-reflection; reviewing and analyzing student survey results and outcomes data; and strategizing process improvement based on data analysis.

Mt. SAC submitted the following new grant applications in the third quarter of FY 2022-23:

4. California Community Colleges Chancellor's Office – Equal Employment Opportunity: Innovative Best Practices
 - The proposed project administrator is Dr. Sokha Song, Vice President of Human Resources.
 - The request is \$300,000 over a two-year period.
 - If awarded, this project would: (1) develop and implement a formal, evidence-based DEISAA employee mentorship program to support probationary employee success, including for those from underrepresented groups who have historically been subjected to discrimination and marginalization in employment policies and practices; and (2) create an alternative dispute resolution process using restorative justice to informally resolve complaints of discrimination and other disputes among employees.

5. U.S. Department of Education – Title III/V Designation
 - This eligibility application is required annually to receive funding as a Hispanic-Serving Institution (HSI) or an Asian American and Native American Pacific Islander-Serving Institution (AANAPISI).
 - Eligibility also grants a waiver of the non-Federal share matching requirement under the Federal Work Study Program, the Federal Supplemental Educational Opportunity Grant Program, the TRIO Student Support Services Program, and the Undergraduate International Studies & Foreign Language Program.
 - The college was deemed eligible.

6. National Science Foundation – Scholarships in Science, Technology, Engineering, and Mathematics (S-STEM)
 - The proposed project lead is Eugene Mahmoud, Professor of Engineering.
 - The request is \$2,500,000 over a six-year period.
 - If awarded, this project would create a scholarship cohort experience for Engineering and Engineering Technology students. This would include: providing need-based scholarships to academically talented students; advocating for student success through faculty mentorship, staff-supported peer cohorts, and professional networking for the duration of each scholar's award; and curating and facilitating additional, novel support and co-curricular activities for students. The project will conduct program evaluation from an evidence-based research, culturally responsive, holistic approach.

Mt. SAC submitted the following new grant applications in the third quarter of FY 2022-23:

7. California Community Colleges Chancellor's Office – Mathematics, Engineering, Science Achievement (MESA)
 - This application was submitted and was in the process of being awarded during the third quarter.
 - The project administrator is Dr. Denise Bailey, Dean of Natural Sciences.
 - The award will be \$1,400,000 over a five-year period.
 - This project will implement a MESA Program that will serve underserved and underrepresented students majoring in calculus-based STEM fields who seek to transfer to a four-year institution. Activities will include outreach, counseling, individualized educational plans and academic success monitoring, career advising, career preparation workshops, non-cognitive skill development, academic excellence workshops, one-on-one and group tutoring, organized study groups, guest speakers, leadership seminars, student club activities, transfer workshops, assistance with the transfer institution and financial aid application processes, cultural and personal enrichment field trips, visits to four-year colleges and universities, recognition activities, family engagement, and other academic and student support services.

8. Congressionally Directed Spending Request – Pathways to Jobs
 - The proposed project administrator is Dr. Madelyn Arballo, Vice President of School of Continuing Education.
 - This was the first phase of a potential multi-step process. The initial request for \$570,000 was submitted to Senators Feinstein and Padilla for consideration.
 - If awarded, this project would increase the numbers of adult learners enrolled in noncredit programs who transition to credit vocational degree, certificate, and licensure programs at Mt. SAC. The project will facilitate a successful transition for adult learners by preparing them for credit enrollment, providing support throughout the matriculation process, and offering wraparound services to address any barriers they face before or during enrollment.

9. Congressionally Directed Spending Request – Wildland Fire Training Program
 - The proposed project lead is Ray Mosack, Director of Public Safety Programs.
 - This was the first phase of a potential multi-step process. The initial request for \$534,122 was submitted to Senators Feinstein and Padilla for consideration.
 - If awarded, this project would prepare students for high-wage jobs in wildland firefighting and prevention. To operate at optimal capacity, the program requires the purchase of specialized supplies and equipment and also seeks to offset the cost of required gear, supplies, and fees for students, enabling full participation of students from underrepresented backgrounds.

Mt. SAC submitted the following new grant applications in the third quarter of FY 2022-23:

10. California Community Colleges Chancellor's Office – Native American Student Support and Success Program

- The proposed project administrator is Dr. Eric Lara, Associate Dean of Student Success and Equity.
- This was the first phase of a two-step process. If invited to submit a detailed plan, Mt. SAC would be eligible to receive \$1.5 million over a five-year period.
- If awarded, this project would establish a full-time coordinator and tribal liaison for the purpose of service implementation; integrate peer mentorship to link tribal citizens to appropriate campus support services, develop clearly structured, course-specific cohorts for tribal citizens; build capacity for counseling and wraparound student services offering culturally responsive resources; develop and integrate faculty and staff professional development centered on a sovereignty framework; deliver core matriculation services to increase Native American student access and success; and make meaningful progress in relationship-building with local tribes.

11. California Commission on Teacher Credentialing – Integrated Teacher Preparation Implementation and Expansion Grants

- California State Polytechnic University, Pomona, is the lead applicant. Mt. SAC is a partner, along with Citrus College and Chaffey College.
- If awarded, this project would strengthen the implementation of existing Liberal Studies and Early Childhood Studies integrated teacher education program (ITEP) pathways by expanding program capacity and support for ITEP students. Grant activities are structured around four main project goals: (1) streamline junior transfer pathways with a summer bridge, (2) assess and adjust to new executive orders regarding university general education and major programs, (3) assess and revise ITEP advising and mentoring, and (4) strengthen recruitment, retention, and persistence.

12. California Commission on Teacher Credentialing – Integrated Teacher Preparation Implementation and Expansion Grants

- University of California, Irvine, is the lead applicant. Mt. SAC is a partner, along with Orange Coast College and Santa Ana College.
- If awarded, this project would: (1) increase and facilitate broad awareness about and recruitment to the CalTeach math and science secondary single subject credential preparation program for students in community colleges; and (2) promote access to UCI coursework while students are at the community college through cross-enrollment, especially mathematics students who require additional coursework to be on-track for graduating from UCI with a degree plus single subject mathematics credential.

Mt. SAC received award notifications for several new grants:

1. SeedMoney awarded a \$200 grant through the Garden Grants program. This project commenced on January 15, 2023. Funding will support the purchase of supplies for the Mt. SAC Sustainable Demonstration Garden.
2. The National Science Foundation awarded a \$69,430 grant through the Improving Undergraduate STEM Education: Conferences and Workshops program. This one-year project, led by Professor Rebecca Walker, is in collaboration with Highline College (Washington), Reynolds Community College (Virginia), and William & Mary (Virginia). Funding will support a five-day virtual conference for two-year college geoscience faculty to disseminate results from the NSF-funded *Supporting and Advancing Geoscience Education in Two-Year Colleges: Faculty as Change Agents* project.
3. The California Department of Health Care Access & Information awarded a \$210,000 grant through the Song-Brown Health Care Workforce Training Program: Registered Nurse (RN) Education Programs. This project will commence on July 1, 2023, for a two-year project period. Funding will support the training of RN students, including clinical hours in a simulated healthcare setting, hiring clinical teaching assistants to provide supplemental instruction, tutoring, and test preparation to improve program retention.
4. The California Community Colleges Chancellor's Office awarded a \$120,000 planning grant through the California Apprenticeship Initiative. This project will commence on July 1, 2023, for a one-year project period. Funding will support the registration of a Vocational Nursing apprenticeship program through the Division of Apprenticeship Standards and the preparation for implementation of the apprenticeship program.
5. The California Community Colleges Chancellor's Office awarded a \$1,200,000 implementation grant through the California Apprenticeship Initiative. This project will commence on July 1, 2023, for a three-year project period. Funding will support the implementation of an approved apprenticeship program focused on Pharmacy Technician and Medical Assistant, including outreach and recruitment of apprentices, employer relations, support services, supplemental instruction, and on-the-job-training.
6. The Arthur N. Rupe Foundation awarded a \$25,000 grant through the Certified Nursing Assistant Program. This project will commence on July 1, 2023, for a one-year project period. Funding will support students in the CNA program through tutoring, counseling, expanded lab hours, certification exam preparation, and scholarships.
