Executive Summary

The Measure RR and Measure GO building program is moving forward with all major milestones ahead of schedule, 12 major projects on schedule and within approved budgets, and two major projects on budget, but delayed up to six months. Expenditures for the 2021/2022 fiscal year exceeded \$120 million, including \$85.3 million from Measure GO, \$18 million from Measure RR, and over \$20 million from State Capital Outlay funds.

The current master project list includes 198 projects, including 10 new start projects, 15 in the closeout phase as final items are completed, 16 projects completed in the last quarter, and 23 projects on hold pending project management assignments. The following chart shows the status and occupancy dates for select major capital construction projects:

Administrative Activities

This quarter began with four open management positions in the construction administration, planning, and design and construction teams. Valerie Arenas-Rey was selected as the new Assistant Director for Capital Construction Programs, and formally approved for the position at the August 10 Board of Trustees meeting. Valerie will lead the team responsible for maintaining real-time financial records and budget reports for all construction activities, including State Capital Outlay, and other special funds. Her team will provide a single point of contact for the project management and planning teams for all items related to procurement and project funding, Valerie will work closely with the purchasing and fiscal services offices to ensure compliance with public contract code, administrative procedures, and best practices, and she will oversee fixed asset tracking and community workforce coordination. Valerie has been with the college for over five years as a special projects director and has developed and updated many of the internal processes that support the large volume of construction activities on campus.

Three vacant positions remain to be filled, including the senior facilities planner. This position will require additional recruiting efforts as the first search did not result in a successful hire. Nafiseh Kaeni has stepped up to handle some of the duties of the senior facilities planner, however a number of planning projects remain on hold, including the educational and facilities master plan update scheduled to begin in the fall. Two project management positions also remain vacant. The hiring committee has been established for the senior manager, construction projects position, vacated with the retirement of Roger Sneed. The special project manager position vacated with the retirement of Ruben Avila has been temporarily filled with a professional expert while the recruitment is underway.

The team continues to perform very effectively in all areas, with the senior project managers overseeing multiple major projects or large portfolios of smaller projects. Changes in two areas are currently under consideration. With the retirement of Roger Sneed, the team has lost a great resource in the areas of general field supervision and construction safety oversight. Mike Ostby has stepped up to fill this gap by taking the front line responsibility for reviewing method statements and observing critical activities in the field on all projects, consulting regularly with the Tilden Coil Constructors safety management team, and working closely with risk management. In addition to his regular project management responsibilities, Mike has begun advanced coursework in safety management through the University of California extension, and will begin regular meetings with the inspection teams responsible for quality assurance and code compliance. Recommendations to formalize these additional responsibilities will be made at an upcoming CMPCT meeting.

Changes to our process for completing small furniture and equipment projects are also under consideration. With the new recycling and reuse center expected to open this fall, we will have a new centralized work area and storage space for warranty and other repairs and for reconfiguring and repurposing office and classroom furniture and equipment. Doing this work with in-house resources will improve timelines and reduce costs for the many small projects of this type. Recommendations to formalize the operation of the recycling and reuse center will made at an upcoming CMPCT meeting.

Planning Projects

The planning team remains focused on the capital outlay planning submittals required by the Chancellor's Office, including the five year construction plan, the annual space inventory update, and the upcoming facilities condition index report. The team updated and resubmitted the final project proposal (FPP) for the library replacement project, and created three new initial project proposals to assess the competitiveness for state funds for a new student services building and for modernization work at the existing library and the existing student services building. More detailed project planning for future facilities including the proposed new student services, science laboratories, and fine arts buildings is on hold pending successful completion of the recruitment for the new senior facilities planner.

Progress is also being made in the document resource center. In addition to supporting construction and maintenance activities with readily available detailed as-built construction documents and product data, the team continues to develop campus-wide parking and topographic data to support project development and decision making. The team continues to develop greater capacity to prepare biddable construction documents for small alteration projects that do not require DSA review. Recently completed documents for the building 28 plumbing system repairs, and the dual enrollment program space improvements in building 6 have saved the college significant engineering and architectural costs.

California Environmental Quality Act (CEQA) Compliance efforts continue with the completion of the Technology and Health final CEQA approval in June, and approval by the Board on August 10 of the resolution in support of the initial study and mitigated negative declaration for the emergency communications tower replacement project.

Scheduled Maintenance and Instructional Equipment

Efforts to reduce the deferred maintenance backlog and update instructional equipment across campus continue with substantial progress made on the largest projects, including accessibility and water infrastructure improvements, and major upgrades to the campus chilled water central plant. A detailed report including recommendations for the current fiscal year funding will be presented at the September 20 CMPCT meeting. A recommendation has already been made to use up to \$5 million of the \$21 million allocated for the 2022/2023 fiscal year for instructional equipment for the new Technology and Health facility. Efforts to improve instructional technology in older buildings such as math and science (61), science laboratories (60), and humanities and social science (26) will begin in earnest later this year.

Major Capital Projects and Sustainability

A detailed report focusing on major capital projects and sustainability efforts related to measure GO was presented to the Board of Trustees on August 10, 2022. A copy of the report is attached for reference, with minor edits to reflect the most recent information.
