

President's Cabinet Action Notes October 24, 2023

- 1. Cabinet reviewed and commented on the following standing items:
 - a. Marketing and Public Affairs provided the following updates to Cabinet:
 - The American Green Zone Alliance (AGZA) has certified Mt. SAC as an AGZA Green Zone campus; the first community college in the country to earn this designation. Press releases have been sent out celebrating this acknowledgment. A Certification Ceremony is being held on November 2nd, from 11:00 a.m. to 1:00 p.m. at Heritage Hall.
 - Loma Media is working on scheduling interviews with campus members to receive feedback regarding the Mascot change.
 - The Ocelot chatbot project has been delayed due to a technical issue that is being resolved. Yen will be including all divisions in the initial planning process.
