Drop for Non-Payment Analysis - Summer 15 6/25/15

One of the outcomes of our 320 report meeting was to analyze the drop for non-payment process, which it seemed had a significant impact on enrollment for Summer 15. See the attached spreadsheet. I analyzed the credit headcount and the projected FTES before and after each drop date and compared it to similar dates in 14.

Summary - First drop in 15 was large (headcount went down 1,657), but percentagewise was similar to 14 (-11.34% vs -12.46%).

Second drop in 15 was minor (headcount went down 324). Due to a technical issue, the second drop in 15 for summer did not occur, so we have no similar comparisons.

After the first day of summer session 15, headcount was up (slightly: + 82) over the headcount prior to the second drop, so most of those drops were recovered by late add activity.

Overall headcount and FTES after day 1 of the semester is up over 14, but not by as much as anticipated (5.49% and 4.61% respectively).

One thought - the first DFNP for summer occurs at the end of Finals week. I'd be curious to know how many of these students were preemptively registering in the same class that they were taking during Spring semester, anticipating the need to repeat and letting the class drop once they know they received a passing final grade. Another question would be - how many students were taking a prerequisite course in Spring for a summer course, but let the summer course drop after receiving a failing grade.
