### **Expansion Plan For EEO Representative Training**

(9/23/14)

#### **Current Process:**

- **General EEO Training** "Hiring the EEO Way" (either webinar or in person) is offered through Liebert, Cassidy, Whitmore (LCW), and advertised through POD. (4 hours)
- **Tracking**, all individuals who complete training are tracked by date completed and constituent group, and are eligible to serve as an EEO Rep.
- Screening and Selection Committee Training offered throughout the year.
- Training for Chairs and Selection Committees Members is also provided "just in time" training as needed.

#### **Proposed Process:**

- Specific in-person Training for EEO Representatives, "Understanding Your Role and Responsibilities as an EEO Representative" (3 hours)
  - o Provide at least **twice (2x) each term** (Fall, Spring and Winter) for those who would like to serve on as an EEO Rep within 1 year . Provide morning, afternoon, evening options to be accessible to all constituent groups.
  - Provide "Just In Time" to identified EEO Reps and Chairs
  - Encourage known and potential Chairs to participate in EEO Rep training when possible.
- Viewable List of Qualified "Certified" EEO Reps, sorted by constituent group, available on HR website.
  - Regularly reach out to constituent groups to populate pool of readily available EEO Reps.
  - o Annual email announcement "call for EEO Reps."
  - Announce upcoming searches to constituent groups when positions are first approved, in order to identify possible EEO Rep and committee members as much in advance as possible.
  - Existing EEO Reps will be invited to participate.
- General training for all members of selection committees
  - Three (3) hour, in-person training that incorporates recent Title 5 changes.
  - Provide at least twice (2x) each term (Fall, Spring and Winter). Provide morning, afternoon, evening options to be accessible to all constituent groups.
  - o Targeted to individuals who will likely serve on a selection committee within one year.
  - Provide "Just in Time" to committees and/or committee members when needed.
