The application included support from more than 200 business partners, including DoubleTree by Hilton Monrovia, Industry Manufacturers Council, Kaiser Permanente, Methodist Hospital, Southern California Edison, and the Southern California Association of Governments.

SECTORS

Our application includes four CTE Industry Sectors: Business and Finance, Health Science and Medical Technology, Manufacturing and Product Development, and Public Services.

Business - Students will earn articulation credit, receive transition services, and be encouraged to complete a level 1 certificate in their first semester at college.

Health Science- Students will be given the opportunity to complete training as CNA no later than the summer between graduation and the fall semester of college. Students will be encouraged to complete Home Health Aid certification during their first year in college.

Manufacturing & Product Development-Students will complete the first two courses in the Industrial Design Engineering Level I certificate while in high school and receive credit through articulation. Students may use early college start or dual enrollment to complete the third course at Mt. SAC. Students will have the opportunity to graduate with Level I certification completed and be guaranteed entrance into the Level II cohort.

Public Services- Students will earn credit in two Mt. SAC courses during high school, receive transition services, and be encouraged to complete the Law Enforcement certificate at Mt. SAC.

BUDGET

When preparing the application budget, funds were allocated for everything that was requested except items that were not allowable per the RFA (e.g., furniture not for use by students, food services/refreshments, promotional supplies) and full-time instructional salaries, which in most cases would be considered supplanting.

Please note that the final budget had to be submitted as a whole, and did not allow for significant detail for each partner.

The Department reserves the right to fund us at the requested level, or at a lesser level. If we are funded, we will schedule one-on-one meetings with your districts to set-up more specific line-item budgets and statements of work.

PROGRAM OUTCOME MEASURES

- Increase the number of high school graduates placing into college-level English and math.
- Increase the number of industry-validated skill certificate completions.
- Increase the number of students that transition from high school to college in the identified career pathways.
- Increase the number of high school students graduating with college-level credits.
- Increase the number of students participating in work-based learning experiences.

NEXT STEPS

CCPT applications are being read and scored during the period of February and March

Successful applications, based on scoring, will be invited to an interview in Sacramento. The grantee award announcement will be in May.

If successful, the grant period would begin on June 1, 2015.
