# Title IX of the Education Amendments Act of 1972

"No person in the United States shall, on the basis of sex, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any education program or activity receiving Federal financial assistance."

"Title IX protects everyone from being mistreated based on sex (gender) or gender identity"

# Campus Sexual Violence Elimination (SaVE) Act



- Violence Against WomenAct Reauthorization2013
- Became effective March 7, 2014. Final regulatory language released on October 20, 2014
- Rules went into effect July 1, 2015
- Sexual Violence will not be tolerated at Mt SAC

#### SaVE Act

- Sexual Violence awareness education to all incoming students
- New Employees awareness and training
- Ongoing prevention and education
- Includes definitions of Sexual Assault, Rape, Domestic Violence, Stalking and Dating Violence.
- What to do if you are assaulted?
- Policies and procedures in place
- Consent, yes means yes

#### SaVE Act

- Teach Bystander prevention
- Changes in procedures for the institutional disciplinary action cases, to include:

Prompt, fair, and impartial investigation and resolution Conducted by officials who receive annual training How the institution will protect the confidentiality of victims and protect the victim with accommodations

# SB 967-Affirmative Consent Law

- Policies must include an "affirmative consent" standard for determining whether consent was given by both parties to sexual activity.
- Mirrors Title IX mandate for preponderance of evidence standard for complaints of sexual assault.
- Requires the adoption of "detailed and victimcentered policies and protocols" regarding sexual assault, dating and domestic violence and stalking involving students.
- In addition to mirroring Federal training requirements for incoming students, SB 967 mandates the implementation of "comprehensive prevention and outreach programs..."
- Mandates MOUs between institutions and local law enforcement and community based organizations.
