### **CRIMES RELATED TO COLLEGE CAMPUS**

#### **I. Trespass Crimes**

##### **A. Trespass – Entering and Occupying Real Property – 602(m) PC (misdemeanor)**

1. Entering and occupying
2. Real property or structures of any kind
3. Without consent of the owner, the owner's agent, or the person in lawful possession
4. Refusing to leave upon request

##### **B. Trespass on Campus – Suspended/Dismissed Student/Staff– 626.2 PC (misdemeanor)**

1. Willfully and knowingly enters on the campus or facility
2. Without the express written permission of the chief administrative officer of the campus or facility
3. By a student or employee who has been suspended or dismissed from a community college for disrupting the orderly operation of the campus or facility of the college, and has been denied access to the campus or facility for the period of suspension (or for a dismissal for a period not to exceed one year) and who has been served with written of the suspension or dismissal and the condition

##### **C. Trespass on Campus – Willful Disruption – 626.4 PC (misdemeanor)**

1. Willfully and knowingly enters or remains on the campus or facility
2. By any person who there is reasonable cause to believe has willfully disrupted the orderly operation of the campus or facility and
3. Who has been notified by the chief administrative officer or designee that consent to remain on the campus or facility has been withdrawn (for up to 14 days)

##### **D. Trespass on Campus – Interfering with Peaceful Campus Activities – 626.6 PC (misdemeanor)**

1. Willfully and knowingly enters or remains on the campus or facility
2. By any person who is not a student/employee where it reasonably appears the person is committing any act likely to interfere with the peaceful conduct of the activities of the campus or facility, or has entered the campus or facility for the purpose of committing such an act has willfully disrupted the orderly operation of the campus or facility and
3. Who has been directed to leave the campus or facility (for up to 7 days)

**II. Crimes Against Persons**

**A. Assault on School Property – 243.5 PC**

1. When a person commits an assault or battery on school property during hours when school activities are being conducted, a peace officer may, without a warrant, arrest the person for assault or battery
  - a) Although not in the peace officer's presence
  - b) Whenever the peace officer has reasonable cause to believe that the person to be arrested has committed the assault or battery

**III. Threats**

**A. Stalking – 646.9 PC (misdemeanor)**

1. Willfully, maliciously, and repeatedly
2. Follow or harass another person
3. And make a credible threat
4. With the intent to place that person in reasonable fear for his or her safety or the safety of his or her immediate family

(A credible threat is one that causes the target of the threat to reasonably fear for his or her safety [or for the safety of his or her immediate family] and one that the maker of the threat appears to be able to carry out. A credible threat may be made orally, in writing, or electronically or may be implied by a pattern of conduct or combination of statements and conduct.)

**B. Threatening a Public Officer – 71 PC (felony)**

1. With intent to cause
2. Attempt to cause or cause
3. Any officer or employee of any public or private educational institution or any public officer or employee
4. To do or refrain from doing
5. Any act in the performance of their duties
6. By means of a threat
7. Directly communicated to the person
8. To inflict an unlawful injury upon any person or property, and
9. It reasonably appears that the threat could be carried out

**IV. Alcohol Possession Crimes**

- A. Possession of Alcoholic Beverages on Public School Grounds – 25608 B&P (misdemeanor)**
1. Possess, consume, sell, give, or deliver to any other person,
  2. Any alcoholic beverage
  3. In or on any public school house or any of the grounds
  4. Enforceable 24/7

**V. Weapons Possession Crimes**

- A. Unlawful Possession or Use of Tear Gas Weapon – 22900 PC (misdemeanor)**
1. Possesses
  2. Any prohibited tear gas or tear gas weapon (expels projectiles, expels other than as an aerosol, or contains more than 2.5 ounces of spray)
- B. Unlawful Use of Tear Gas Weapon – 22810 PC (felony)**
1. Use
  2. Any tear gas or tear gas weapon
  3. Not in self-defense
- C. Possession of Knives on College Grounds – 626.10(b) PC (felony)**
1. Possess a dirk, dagger, ice pick, knife having a fixed blade longer than 2.5 inches
  2. On the grounds of a college
  3. Without written permission of the college president
- D. Possession of Less Lethal Weapon or Stun Gun on College Grounds – 626.10(i) PC (misdemeanor)**
1. Possess a less lethal weapon or stun gun
  2. On the grounds of a college or university
  3. Without written permission of the college president or designee
  4. Except for a lawful purpose within the scope of employment

**VI. Firearms Possession Crimes**

- A. Possession of Loaded Firearm on College Grounds – 626.9(h) PC (felony)**
1. Possess a firearm
  2. On the grounds of a campus of, or buildings owned or operated for teaching or administration of, a college that are contiguous or clearly marked university property
  3. Without written permission of the college president or designee
- B. Possession of Firearm on College Grounds – 626.9(i) PC (felony)**
1. Possess a firearm
  2. On the grounds of a campus of, or buildings owned or operated for teaching or administration of, a college that are contiguous or clearly marked university property
  3. Without written permission of the college president or designee
- C. Bringing Firearm or Other Unauthorized Weapon in a Prohibited Location – 171b PC (felony)**
1. Bring or possess
  2. A firearm, switchblade knife, other prohibited weapon under 16590 PC, any knife with blade longer than 4 inches that is fixed or capable of being fixed, unauthorized tear gas, taser or stun gun, or BB or pellet gun
  3. Within any state or local public building, or
  4. To any meeting required to be open to the public

**VII. Unlawful Use of Weapons Crimes**

- A. Drawing/Exhibiting Loaded Firearm on the Grounds of Any Daycare Facility – 417(b) PC (felony)**
1. In the presence of any other person
  2. Draw or exhibit any loaded firearm in a rude, angry, or threatening manner, or
  3. Unlawfully use a loaded firearm in any fight or quarrel on the grounds of a day care center when that center or facility is open for use,
  4. Except in self defense
- B. Display or Expose Imitation Firearm in a Public Place – 20170 PC (infraction; misdemeanor for 3<sup>rd</sup> offense)**
1. Openly display or expose
  2. Any imitation firearm
  3. In a public place (street, sidewalk, park, parking lot, automobile, public college)
