It is recommended that the Board of Trustees authorizes the approval of an agreement between the School of Continuing Education and Futuro Health for a health careers programs partnership that will provide funding to students for

program expenses.

## **BACKGROUND**

The School of Continuing Education (SCE) is requesting authorization to enter into a contract with the Futuro Health organization. Futuro Health is a non-profit organization focused on improving the health and wealth of communities by growing the talent that employers need and creating a path to opportunity for prospective healthcare workers. They partner with educational institutions that have programs in high-demand healthcare fields and provide scholarships to pay for tuition, support services, or any out-of-pocket program costs associated with students' training. This contract with Futuro Health will engage Mt. SAC as an independent contractor to provide training to students enrolled in noncredit health careers programs such as Emergency Medical Technician Program, Certified Nursing Assistant, Medical Assistant, Pharmacy Technician, and future health careers programs in exchange for funds paid per student by Futuro Health. Costs covered by these funds are for textbooks, equipment, supplies, testing fees, and any other expenses associated with the program.

## **ANALYSIS AND FISCAL IMPACT**

Futuro Health will pay Mt. SAC up to \$6,000 per enrolled noncredit student to cover the program costs for the related health careers program. Mt. SAC will invoice Futuro Health for these per student costs and then pass the payments directly to the students. The agreement is effective on December 14, 2023, and shall continue through December 31, 2024.

The project will not impact the College budget.

Funding Source

Not applicable.
