1 Review/approve May 6, 2015 meeting minutes		Minutes were approved as amended.		
2	Announcements	Please submit your Spring 2016 teaching requests to Terri by Friday, May 15 <sup>th</sup> .		
3	O-chem discussion	There was much discussion on a variety of items that relate to our Organic Chemistry program. The dept agreed that all FT faculty in dept are equally eligible to teach o-chem courses, and no faculty will be designated as "hired to teach o-chem courses". The dept agreed to begin the following policies regarding the teaching of our o-chem courses (Chem 80 and Chem 81):  1) New o-chem policies begin with Spring 2016 term (with an exception for Jody if she desires to teach o-chem a second term after Fall 2015 to complete her rotation).  2) No more than 5 o-chem courses scheduled per semester, due to scheduling issues, and lack of FT day-time stockroom support and evening support in bldg 7. O-chem courses schedule only during day time for now.  3) At least 2 FT faculty should be teaching o-chem courses (either) during a Fall or Spring term At least one FT o-chem faculty must be experienced (to be defined later) in teaching o-chen courses.  4) Faculty willing to teach o-chem courses will be given opportunities to teach whenever they volunteer.  5) All dept FT faculty will rotate through a year (a Fall term + a Spring term) of teaching o-chen then may take a break until all others have rotated through if so desired.  6) O-chem faculty will be "selected" from a pool of eligible FT faculty whenever there less thar 2 volunteering FT faculty are teaching o-chem courses. Selection of o-chem faculty will be from a pool made up of FT faculty who have not completed an o-chem year rotation.  7) Faculty volunteering to teach o-chem courses may displace "selected" o-chem faculty from the schedule, causing a delay of the start of the selected faculty's rotation year.  Todd was selected to begin his rotation year teaching o-chem courses, starting with the Spring 2016 term.  Additional discussion will continue at a future meeting to address other important issues surrounding the o-chem program:  • volunteering of faculty to begin rotations  • requesting another FT stockroom technician  • cleaning/organizing the Instrument Room  • i
