Whereas: The A.S. Vice-President attends 31 meetings per month (26.25-39 hours), also arranging a minimum of 6 office hours per week; comparable to a part time job.

Whereas: During Fall and Spring semesters, the A.S. VP will be given a stipend of \$250 per month. The stipend will come from A.S. general funds and dispersed through student life.

Whereas: The A.S. VP will be penalized for any unattended meetings. The percentage deducted from their stipend will be 2.5x the percentage of meeting per month unattended. Upon impeachment or resignation, the A.S. VP will no longer receive a stipend.

Whereas: A large portion of Mt.SAC students work part time. With the job duties of the A.S. VP, it is financially infeasible for many students to be the A.S. VP. With a stipend, the A.S. VP position will be made accessible to a large, representative demographic of Mt.SAC's student creating a diverse pool of candidates.

Whereas: The Financial Directive will be revised to reflect this change.

Therefore: Be it resolved, that the A.S. Senate, the A.S. Executive Board, and the A.S. President approve the Vice-President Stipend.

Monthly Meetings of

A.S. Activities Meeting

- 1 hour * 4 per month = 4 hours/month

+

A.S. Senate Meetings

- 1.5 hours * 8 per month = 12 hours/month

+

Executive Board Meetings

- 30 minutes * 4 per month = 2 hours/ month

+

Biweekly President's Cabinet Meeting

- (1-2 hours) * 2 per month = 2-4 hours/month

+

Weekly Meeting with A.S Advisor

- (1-2 hours) * 4 per month = 4-8 hours

+

Monthly Meetings with Activities (2), Arts, Athletics, Cross-Cultural, Environmental, Historian, ICC, and Publicity Senators individually

- (15 minutes – 1 hour) * 9 per month = 2.25 – 9 hours/month

Total Meetings / Month = 31 Meetings / Month

Total Hours / Month = 26.25-39 Hours / Month

Other Responsibilities

Board of Trustees Meeting

- (3-4 hours) * 1 per semester = 3-4 hours

Office Hours

- 6 hours * 4 weeks = 24 hours

Total of all hours spent on A.S. business = 205 – 256 hours / semester

Missed Meetings

% missed meetings * 2.5 = % deducted from stipend

Example: 7 missed meetings/35 meetings = 20%

20% * 2.5 = 50% deduction of that months stipend

VII. OTHER

G. Stipends

The Associated Students President shall receive a stipend of 25% more than that of the Student Trustee. The stipend shall be given monthly by the Student Life Office.

The Associated Students Vice-President will receive a stipend, given monthly during Fall and Spring. In the event of impeachment or resignation, the former A.S. President or Vice-President will not receive a stipend. There shall be a penalty of 2.5x the percentage of unattended meetings deducted from the stipend.

VIII. AMENDMENTS

This Directive may be amended by submitting the amendment(s) as a Bill to the Senate and Executive Board. A two-thirds (2/3) vote of the quorum present is required by both. The Bill will then be forwarded to the A.S. President for approval. The approved amendment(s) will be effective immediately.
